We would be happy to reestablish our connection with Schleswig-Holstein and explore opportunities to work together in the future. Should you have any questions, please feel

In light of evolving geopolitical dynamics and in alignment with the European Commission's 2024–2029 agenda, the strategy has been recalibrated to strengthen regional leadership in key areas such as maritime spatial planning, clean energy, smart mobility, the circular economy, skills development, and climate adaptation. Rather than marking a conclusion, this review sets a clear course for the next phase—one that is inclusive, forward-looking, and rooted in the shared strengths of our member regions. Together, we will continue to shape a North Sea Region that is not only prepared for the future but actively defining it.




*The North Sea Commission is made up of 27 member regions from 8 different countries.*

## Looking Forward

- One of the engaged member regions is leading efforts in an Erasmus+ project focused on Blue Skills and fisheries. The working group will be looking into the significant potential for collaboration that goes beyond the scope of this project. As well as, looking into how opportunities are -and can be- harnessed for broader cross-sectoral impact.
- To supplement their work on Marine Spatial Planning, the group is beginning to draft a framework for a project focused on decision support systems, public participation, and stakeholder engagement in marine and coastal planning.
